I agree not to use the logo/s for any other purpose beyond those listed above including allowing another individual or business to use the logo/s. I also agree not to alter or change the logo in any way other than adjusting it for size, and to display the logo at least 72 dpi. If I violate this agreement the department will rescind all rights to my usage of the logo and I will be dropped from the program.
